## Highlights--Monthly Meeting for Business

Second Month 18, 2007

**Minutes of business meetings** will be handled a little differently. At the time an action is taken during a business meeting, the recording clerk will read aloud a proposed minute for approval. Soon after, the minutes will be posted on the bulletin board for all to peruse.

Two generous **bequests have been received from the estate of Charlotte Ritter**. Contribution income is slightly down; however our **finances** are in satisfactory condition. Friends are delighted with the excellent new projection equipment, screen, and room-darkening shades in the Worship Room.

**Ministry & Counsel** would appreciate help from Friends outside the committee with the workings of the **Winter/Spring Series** of events.

A **memorial minute for Charlotte Ritter** is nearing completion. **Memorial minutes for Jerry Wood and Lorraine Schmidt** are in process.

It is time to begin considering what to say in the **2006 State of the Society Report**. The first half-hour of the March business meeting will be devoted to worship sharing on this topic. Also, there will be a second-hour conversation on this topic following worship on April 1.

Responsibility for **greeters and closers of Meeting for Worship** has been shifted from Ministry & Counsel to the Meeting for Business.

**Peace & Social Concerns** will be responsible for a visit from Holly Baldwin and a Young Adult Friend from El Salvador, Raul Perez Chacon. This will take place on or about March 19 in the evening. Please join us for supper, silent worship, and conversation with Raul.

**Meetinghouse & Grounds** has planned Work Hours from April through October. They will be: April 22, May 13, June 24, August 5, September 9, and October 14.

**Business meetings will be held on the third Sunday of the month year-round** on a trial basis until October. It was felt that there were several reasons to move away from the traditional Friday evening meetings during the months with Daylight Savings Time: inconvenience for Friends who are employed, extra driving, night driving, and late hour for seniors.

### **WORDS ON WORSHIP**

This month we bring to you a writing about vocal ministry from the second draft of the NEYM *Faith & Practice* chapter on worship. As we wait in expectant silence, whether in an unprogrammed meeting or during the open worship of a programmed meeting, we may find that a message is forming in us. We ask ourselves whether it is meant for us alone or needs to be shared with the meeting, and whether it is to be shared at this time. It is important to allow silence between speakers for the message to be heard and absorbed back into the fabric of the meeting. Friends may need to be particularly vigilant in this discernment when worshipping in very large groups where too many and too frequent messages often leave insufficient time for silence, while smaller meetings may yearn for more vocal ministry. Those who offer ministry may experience physical sensations: many Friends speak of feeling compelled to stand, of their body trembling or their heart pounding. Others find that the message will not be set aside and needs to be expressed. Brief prayers and short messages are equally welcome, as long as the speaker remains faithful to the motion behind the words. If others have already spoken, their words may have led to this message, but in no sense is the speaker “answering” another. The messages during worship may seem to have nothing to do with each other, or they may all seem to follow a single theme. It is customary to speak only once during a meeting for worship. Ministry is expected to be appropriate to the worship setting; there are other forums for personal or social concerns.

## **Ministry & Counsel's Outreach Programs: *What's Happened So Far and What Is Coming***

Last fall, the Meeting began a project to increase its outreach to the community. It approved Ministry & Counsel's recommendation that we plan events that would include the public and Jean Crawford's offer to write articles about upcoming events. Ministry & Counsel also recommended that we purchase projection equipment and room-darkening shades so that we could screen films, and the Meeting approved.

Following four very successful programs in the fall, we are now in the midst of a Winter/Spring Series that promises to be at least as successful. Participation by the public has been gratifying, and we believe the observed increase in visitors to Meeting for Worship is at least partially attributable to increased awareness.

Guy Marsden's "Sustainable Living" workshop took place on the evening of January 30. Turnout was plentiful, and audience participation by Friends and visitors alike was enthusiastic. Guy spoke from his own experiences concerning sustainable living practices small and large. There was special interest in Guy's conversion of his barn/workshop and his domestic hot-water system to solar heat.

Andy Burt's workshop, "The True Cost of Food," on February 11 and a preceding light lunch, provided by the Hospitality Committee, were also well attended, with many visitors from the public. Andy screened the Sierra Club's film *The True Cost of Food* about the detriments of "factory farms." Jean Matlack from the Rockland Universalist Church told about her congregation's relationship with a local farmer; then the farmer gave further useful information on how Community Supported Agriculture can help all involved. We also heard from Amy Bruckstead from Morris Farm.

The next Winter Series event will be a "Workshop on Torture" by Carmen Lavertu, March 25, at 12:30 p.m.

Ministry & Counsel has organized some events that are not so much for outreach as for the direct benefit of the Meeting. On January 28, Pete Haviland led us in a second-hour conversation on the sense of the meeting. We considered how meeting for business can be at least as worshipful as meeting for worship and how the sense of the meeting goes beyond consensus to realization of essential truth.

On March 11, Wendell Stephenson will give a program about Brazil, a brief survey of her land, history, and culture. Wendell and his wife have family living in Brazil, and they spend part of every year visiting there. Wendell emphasizes that, of course, the public is welcome to attend this event.

A daylong retreat is planned for April 21. Our meeting is excited to have a Traveling Ministry Retreat with Christopher & Jean McCandless from Burlington, Vermont. They are dynamic, seasoned Quakers with gifts of vocal and pastoral ministry supporting meeting communities, clerking, peacemaking/conflict resolution/listening, and prayer. They have agreed to facilitate a day-long retreat (9 a.m.-4 p.m.) on "The Testimonies: History and Relevance for Today." They are willing to have up to 30 participants. There will be no charge.
